DELEGATIONS OR VISITORS

Resident of Brushett's Road

A resident requested to attend the meeting to further address her concerns and provide an update regarding ongoing issues with the parking space located adjacent to the turnaround on Brushett's Road. Council advised that the issue is on the agenda to be discussed in the Public Works Committee Report. She was excused at 5:20 p.m.

BUSINESS ARISING OUT OF THE MINUTES

A report of items actioned since the last regular meeting of September 24, 2024 was circulated for review.

- Softball Field Repairs This project is now completed. The field is now closed for the remainder of the year to allow the sods to grow and attach to the soil.
- Capital Works Projects The rescue storage building and Port au Bras water supply projects are progressing, though very slowly.

COMMITTEE REPORTS

Planning & Development Committee

Councillor Farwell, Chairperson, advised that the Planning & Development Committee met on October 7, 2024 and presented the following recommendations:

• Recruitment of Health Care Officials – Councillor Farwell received permission to access a document created by the Burin Peninsula Health Care Foundation for the recruitment of health care officials to our area. The Town Clerk will forward a copy of the document to Councillor Ipads.

- **Dog Regulations** The Committee reviewed an email submitted by a resident regarding dogs not being on a leash. Staff made a post to social media reminding residents to keep all dogs on a leash. The Town Manager will review policies of other Town's and bring back to the Committee for further review.
- Dilapidated Buildings No action was taken on two buildings that owners were requested to remove. Two tenders were received for the removal of the former Appleby's Supermarket. A local real estate agent advised that paperwork is in the process for the sale of the building and the buyer is aware that it has to be removed. One tender was received for the removal of the property on Jorgenson's Road and a motion recommending approval to proceed will be brought forward during the Finance Committee report.
- Public Pathway The Committee was advised that the Town has received several
 messages from residents voicing their concern to not close the foot path located between
 Union Road and Police Road. The Committee recommends that this foot path remain
 open.

• Noise Regulations – Staff have received telephone calls and inquiries regarding loud music at 12 Clearview Drive at various times of the day. A review and possibly a revision of the regulations may be needed. The Committee recommends a letter be written to the property owner.

Public Works Committee

Councillor Foote, Chairperson, advised that the Public Works Committee met on October 8, 2024 and presented the following recommendations:

• Brushett's Road – The Committee reviewed an email regarding residents on Brushett's Road. Council installed a driveway for a resident in recent years to keep them from parking in the turnaround. Unfortunately, a resident located adjacent to the parking area states that she is being harassed by her neighbor. The Committee recommends removing the driveway that was installed by Council.

• Liftstation – The lift station located adjacent to the hospital is now down two pumps. An emergency repair is required to have a new pump installed until the heavier pump is received in approximately six weeks. The Committee recommends purchasing a small pump to keep the lift station operating.

• Heritage Square Tender Results – Only one tender was received for work on the Heritage Square Phase IV project which is pending Government approval. As the prices are within budget of the project, the Committee recommends approval of CASA Construction Inc. for the Heritage Building III upgrades at a cost of \$168,000 plus HST and Courtyard Park Gazebo and Pathway at a cost of \$46,000 plus HST once the funding from government is approved.

• Land - Augustus Drive - The Town Manager contacted a property owner who attended a previous meeting to express concerns that the Town is diverting drain water on to his land located off of Augustus Drive. The owner requested \$17,000 to purchase the property but accepted an offer of \$13,500. The Committee recommends purchasing the land to allow the continuance of run-off.

- Snow Equipment Request The Public Works Director requested that the Town consider purchasing a truck and a loader for this upcoming snow season. As a loader is an expensive item, we would not be able to consider it, however, a new 5500 Series truck will be part of the 2025 budget.
- Staffing Requirement Due to a position recently becoming vacant, the Committee recommends advertising to hire a new full-time labourer for the Public Works Department.

- Big Pond Flow Meter The second new flow meter is not working at Big Pond. Efforts are ongoing to determine what the issue is and to price a new one with surge protection on it. The Public Works Director will report back to the Committee with an update.
- Clean Up Orders The Committee discussed the need to contact some residents and businesses regarding the clean-up of their properties. Also, one resident is required to have a boat removed as it will interfere with snow clearing.

Finance Committee

Deputy Mayor Lundrigan, Chairperson, advised that the Finance Committee met on October 8, 2024 and presented the following recommendations:

• **Liftstation Pump** – The Finance Committee concurs with Public Works that the emergency purchase of a pump for the Liftstation adjacent to the Hospital was necessary.
