### **BUSINESS ARISING OUT OF THE MINUTES**

The Town Manager provided an update of items actioned since the last regular meeting of January 14, 2025:

#### Winterland Road – Crown Land

There is no new information to report on the changeover from the Dept. of Transportation & Works to Crown Lands regarding the former Hickman Property on Winterland Road.

### • Resident Concern – Big Pond Water

The Town Manager spoke with Innovative Engineering to compile a cost estimate to complete a water quality study for the Big Pond water supply.

### **COMMITTEE REPORTS**

### Planning & Development Committee

Councillor Farwell, Chairperson, advised that the Planning & Development Committee met on January 27, 2025 and advised of the following:

- **Resident Request** The Town received a request from an individual who was looking to purchase property in the Town to construct a Phoenix Dome style home. As a Phoenix Dome is not a building similar to properties in the neighbourhood or identified in the Development Regulations, 2010-2020, the Committee cannot recommend that it would be a permitted use in a residential area.
- **Strategic Plan** While there has been much discussion regarding the need for a new Strategic Plan, the Committee suggests that a new plan should be created after the next municipal election in October 2025.

### Public Works Committee

Councillor Foote, Chairperson, advised that the Public Works Committee met on January 28, 2025 and presented the following recommendations:

• **Resident Request – Snow Clearing** – The Committee reviewed a request for the Town of Burin to provide snow clearing on Woody Lane. The Public Works Director visited the area and determined there was sufficient room for the equipment to turn around in the lane.

There were concerns raised that previous requests for snow clearing services were declined in accordance with the Town's Road Standards and why Council would consider this request without fulfilling all current road standards.

• **Big Pond Filtering Screens** – The Committee discussed moving forward with the installation process of filters for Big Pond. The Committee recommends that three prices be obtained for the design and installation of filters for the Big Pond water supply.

- **Big Pond Flow Meter** The Committee was advised that the new flow meter was on site for Big Pond and ready to be installed. The lead contractor for pipe work at Big Pond identified that protection is needed to prevent the meters being destroyed again due to environmental factors. This work will be reviewed and scheduled for when the new Big Pond filters are installed.
- Road Easement Oceanview Place While there are no defined easements within the Town of Burin, the Committee recommends placing an easement of one metre from any municipal infrastructure on Oceanview Place.

- Water Quality Study Big Pond A conference call was held with Innovative Engineering and staff regarding the water quality study for the Big Pond water supply. Innovative Engineering will do a cost estimate and bring back to Council for approval to proceed with an application for funding.
- Excavator As discussed previously, the Public Works Director will gather information that is required to obtain a new excavator through the procurement process and will report his findings back to the Committee. The 160 John Deere has incurred nearly \$80,000.00 in repairs in the past two years and will either be traded or sold.
- **Street Light** The Committee recommends adding a streetlight toward the middle of Warren's Lane and that the light at the intersection be turned towards Main Street to allow for greater visibility in the area.
